ZEDTOWN Event:

Release and Waiver of Liability, Assumption of Risk, and Hold Harmless Agreement

I, the undersigned (“Participant”), have read and fully understand the following. I understand that VStar Entertainment Group, LLC, including its directors, managers, officers, employees, principals, agents, volunteers, and independent contractors (collectively, “VStar”) is relying on this document in allowing me to participate in the ZEDTOWN event (the “Event”). I agree to the following, and intend to be fully bound by the following, in consideration of VStar permitting me to participate in the Event.

EXPRESS ACKNOWLEDGEMENTS OF PARTICIPANT

I understand the following, and affirm and acknowledge that:

- I will be engaging in activities involving **a real risk of serious injury or even death from various causes** including, but not limited to, equipment failure, accidents, interactions with other participants, spectators and Event staff, course or weather conditions, or other causes which may be known or unknown.
- The Event is a lively experience for all participants, and is conducted with rivalry, body contact and active participant interaction. I understand the inherent hazards and risks associated with the Event.
- There are highly similar alternatives to the Event that I could participate in, including but not limited to, paintball, laser tag, and “live-action role-playing” games.
- I am physically fit to participate in the Event and have not been advised otherwise by a medical practitioner. It is my responsibility to monitor my physical condition during the Event, and VStar is not required or expected to have medical expertise beyond that required by law.
- I consent to receiving any medical treatment that VStar considers reasonable during or after the Event.
- The consumption of any alcohol, or illicit or illegal drugs or substances before, during, and after the Event is strictly prohibited.
- Venues are part of the challenge and usually involve environments that might include stairs, grassed slopes or other manmade or natural hazards. I will encounter these; and must engage these hazards as I see fit and appropriate based on my own best sense of my capability and fitness at the time.
- I consent to having makeup applied to me and agree that VStar shall have no liability if I have an allergic reaction to the makeup.

EXPRESS ASSUMPTION OF RISK BY THE PARTICIPANT

I understand the following and voluntarily assume:

- **ALL RISKS OF PERSONAL INJURY, DISABILITY, DEATH, MENTAL INJURY, ECONOMIC LOSS, OR ANY OTHER DAMAGE FLOWING DIRECTLY OR INDIRECTLY FROM MY PARTICIPATION IN THE EVENT, INCLUDING BUT NOT LIMITED TO THE LOSS OF LIFE OR INJURY, TO THE FULLEST EXTENT PERMITTED BY LAW. I ASSUME SUCH RISKS WHETHER CAUSED BY MYSELF, OTHER PARTICIPANTS, OR ANY INDIVIDUAL OR ENTITY RELATED TO OR ON BEHALF OF VSTAR. I ASSUME SUCH RISKS FOREVER, WHENEVER REALIZED OR HOWEVER THEY MAY BE CAUSED, INCLUDING BUT NOT LIMITED TO NEGLIGENCE OR ANY OTHER MISCONDUCT BY ANY INDIVIDUAL OR ENTITY RELATED TO VSTAR OR ON BEHALF OF VSTAR, TO THE FULLEST EXTENT PERMITTED BY LAW.**

EXPRESS RELEASE AND HOLD HARMLESS OF VSTAR FROM LIABILITY BY THE PARTICIPANT

I understand the following and hereby forever release and hold harmless VStar and all persons or entities associated directly or indirectly with VStar or on behalf of VStar from:

- All claims, demands and proceedings arising out of or in any way related to the Event.
- All liability (including liability for their negligence or misconduct and the negligence and misconduct of others, to the fullest extent permitted by law) for all personal injury, disability, death, mental injury, economic loss or any other damage arising out of or connected with the Event.

This Release shall extend to and include, among others, VStar and the Event organizer, partners, managers, officers, employees, agents, contractors, any club, organization and volunteers including medical and paramedical personnel appointed for the Event, the owners, licensees, and occupiers of land on which the activities or any part of it are conducted or which is involved directly or indirectly with the Event in any manner whatsoever and promoters, sponsors and activities organizers (the 'Released Parties'). **This Release and agreement to hold VStar harmless continues forever and binds my heirs, executors, personal representative, beneficiaries, successors, and assigns.** This waiver and release specifically excludes, without limitation, the Released Parties from liability for ordinary negligence in the conduct of the Event and the application of any liability under any civil liability or consumer law applicable to the State in which this Event is held, to the fullest extent permitted by law.

EXPRESS REPRESENTATIONS AND AGREEMENTS OF THE PARTICIPANT

I agree with the following and represent to VStar that:

- I will follow all policies, decisions and instructions, whether written or verbal, of Event personnel.
- I will not use my equipment in any unauthorized manner, or in any manner for which it is not reasonably intended.
- I will not endanger the health or safety of others.
- I will immediately withdraw and notify appropriate personnel if at any point my physical or mental health could create a risk of danger to myself or to others. I agree to assume all reasonable costs of medical care and medically-related transportation caused as a direct or indirect result of the Event.
- I will not hold VStar responsible for any lost or stolen personal property.
- I am not, and on the date of the Event will not be, under the influence of alcohol or any drugs, prescription or otherwise, that would in any way impair my ability to safely participate in the Event.

NAME AND LIKENESS RELEASE BY THE PARTICIPANT

I hereby grant permission to the Event organizers, their successors and sponsors to use my name, image and likeness in direct connection with the Event for promotional broadcasting or reporting purposes in any and all manner and media, unless restricted by privacy laws.

If I am a member of any talent union (including SAG-AFTRA), I will refuse individual direction, or wave my right to compensation. All other image and likeness are non-compensatory based on Section I.8.C.1 in the 2016 SAG-AFTRA Commercial Contract.
